EP-2026.18.i	AG18.i S/HOU/25/1567 – Erection of (proposed) single storey structure to rear of dwelling. 31 Wiltshire Avenue Rodbourne Cheney Swindon SN2 1NX Cllr P Exell explained that the application was discussed previously and the Councillors had no objections. There have been some adjustments to the plans which is why Councillors are asked to review application again. Councillors discussed the application. RESOLVED – NO OBJECTION
